KEY ELEMENTS

Project managed by the EU-funded BizClim program assisting the ECOWAS Commission

Objective: "facilitate the permanent and effective monitoring of the regional investment climate, aimed at ensuring its regular and sustained improvement"

Activities: (i) setting up of a database of investment climate indicators and (ii) development of a related website

Building upon similar experiences (e.g. COMESA)

MAIN STEPS

1 Review of a variety of sources and initial identification of investment climate indicators (over 200)

2 **Consultations** with ECOWAS Commission and selected IPA (reduced the number of indicators, but also some additions)


3 Development of database and website prototype

4 Validation Meeting in Abuja on May 14-15, to firm up structure and contents (only minor modifications)

5 Sensitization Workshop to disseminate information about the system among IPA and other stakeholders

6 Transfer of the system to the ECOWAS Commission which will be responsible for its management, in collaboration with national bodies

OVERVIEW OF INDICATORS

In the database, they are included in two sub headings

Overall Ratings/Rankings: 12 indicators from six main sources (World Economic Forum, World Bank, Transparency International, Freedom House, COFACE, UNCTAD) and dealing with global competitiveness, ability to attract foreign direct investment (FDI), corruption, etc.

Country Risk Indicators: 5 indicators from rating agencies (S&P, Moody's, Fitch), OECD ("consensus") and COFACE

The analysis of these indicators provides an indication of how ECOWAS countries are perceived
